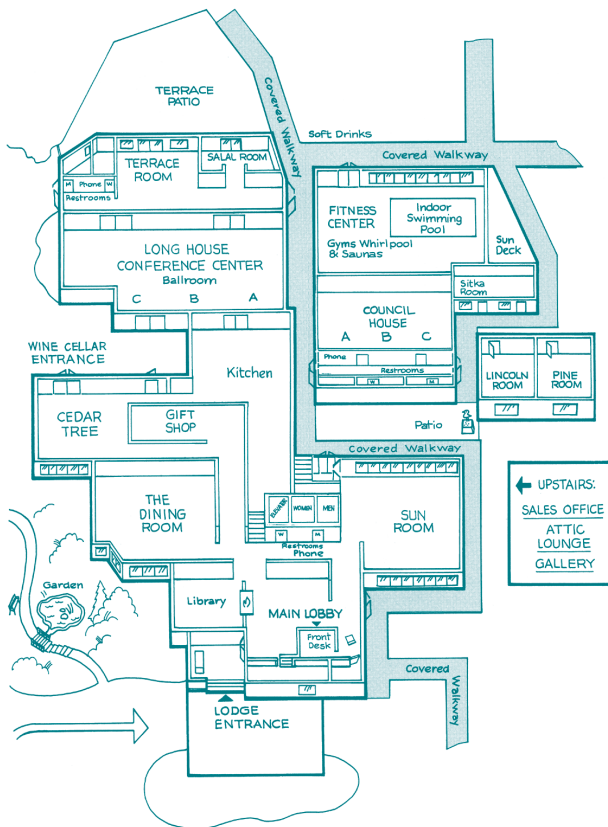
PREREGISTRATION DEADLINE IS JANUARY 4, 2013
